Seats are limited and will be allocated strictly on a **first completed online application basis**.

Technical Requirements & Important Instructions

To ensure smooth submission of your application, please carefully read the following:

1. System & Browser Requirements

- Use the **latest version of Google Chrome** browser.

- Use a **laptop or desktop computer**.
Mobile phones are not recommended as they may slow down your own application process.

2. File Upload Requirements

The portal accepts the following formats only:

- **JPG / JPEG / PNG** (Maximum size: 3 MB per file)
- **PDF** (Maximum size: 5 MB per file)

3. Candidate Information

- Previously registered candidates must enter their **correct 7-digit Candidate ID** to proceed.
- Use only the **email address** you wish to register and correspond with.

4. Required Uploads

- **Scanned signature** (signed on blank white paper)
- **Digital photograph** (JPG or JPEG format only)
- **Valid identification document** (e.g., Passport bio page or National Identity Card)

5. Important Compliance Instructions

- Do not use multiple devices or seek assistance from multiple individuals while completing the application, as this may cause system errors and unsuccessful submission.
- Submission of **duplicate applications** will automatically render the application ineligible.
- In case multiple applications are submitted for the same candidate, **all secured slots will be cancelled**, and such decision shall be final and non-appealable.
- Incomplete applications or uploading irrelevant documents will result in **immediate disqualification**.
- All mandatory fields marked with (*) must be completed; otherwise, the application cannot be submitted.
